July 21, 2016

The County Board of Commissioners met in regular session on Thursday, July 21, 2016 in the Commission Chambers.

Chair Williamson called the meeting to order at 7:00 p.m. Commissioner File provided the Invocation. Commissioner Wagel led the Pledge of Allegiance to the Flag of the United States of America.

#### **CONSENT AGENDA**

Commissioner Ziliak moved, seconded by Commissioner Marchetti, that the following items be voted on at one time by roll call vote and be considered as a consent agenda by the Board of Commissioners:

## **FINANCIAL**

(M-77-16) A motion to approve the purchase of equipment and services provided by BIS Digital, \$12,973.35 and Dell, Inc., \$2,095.06. The total including a 5% contingency is \$15,822.25. The purchase is budgeted in the 2016 Capital budget 245-244-975.018.

(M-97-16) A motion to approve Claims dated 7/15/16.

(M-100-16) A motion to approve the purchase of a Total Station (Accident Investigation and Reconstruction/Crime Scene Mapping) with funds received from the MMRMA Risk Avoidance Program Grant. Purchase from Laser Technology, Inc., in the amount of \$12,335.25, will be paid from account 267-301-701.000.

(M-101-16) A motion to approve an increase in revenue account 101.000.684.000, reimbursement for jail phones, in the amount of \$10,000.00.

#### R-99-16

Commissioner Ziliak moved, seconded by Commissioner Marchetti, to approve the following resolution:

#### **ACT 152 COMPLIANCE**

**WHEREAS**, 2011 Public Act 152 (the "Act") was passed by the State Legislature and signed by the Governor on September 24, 2011; and

WHEREAS, the Act contains three options for complying with the requirements of the Act; and

**WHEREAS**, the three options are as follows:

- 1) Section 3 "Hard Caps" Option limits a public employer's total annual health care costs for employees based on coverage levels, as defined in the Act;
- 2) Section 4 "80%/20%" Option limits a public employer's share of total annual health care costs to not more than 80%. This option requires an annual majority vote of the governing body;
- 3) Section 8 "Exemption" Option a local unit of government, as defined in the Act, may exempt itself from the requirements of the Act by an annual 2/3 vote of the governing body;

**WHEREAS**, Cass County has decided to adopt the 80%/20% option as its choice of compliance under the Act as recommended by the Health Insurance Committee.

WHEREAS, the County has decided to move from a self insured to a fully insured plan;

**WHEREAS**, the County has decided to continue the current prescription plan and spousal surcharge

**NOW THEREFORE BE IT RESOLVED**, the Cass County Board of Commissioners elects to comply with the requirements of 2011 Public Act 152, the Publicly Funded Health Insurance Contribution Act, by adopting the 80%/20% option for the medical benefit plan coverage year September 1, 2016 through August 31, 2017, move from a self funded to a fully funded plan, keep the current prescription plan, and continue the county spousal surcharge and opt out policy.
